



- Maintenance






2022 Airport Layout and Statistics

Total Operations



An operation is a count of aircraft takeoffs or a landings. An arrival and departure counts as two operations.

Source: FAA Terminal Area Forecast (TAF), published March 2022 An enplanement is a count of passenger boardings. It represents the number of passengers that depart SBA. Total passengers at airports like SBA is generally two times the number of enplanements.

2023 Airport Master Plan

- A Master Plan <u>is</u>:
 - A 20-year plan, completed about every 10 years
 - Capital improvement projects
 - Land use compatibility
 - Federal Aviation Administration (FAA) sponsored
 - Meet standards, justify funding
- A Master Plan <u>is not</u>:
 - A business plan or a marketing plan
 - A wish list or funding guarantee
 - A binding document
 - A document that sets policies or rates




